- **HIV:** Pre-authorisation and disease management obtained from **Rx Health on 0861 083 084** – DSP applicable / Non-DSP will reject.
- **Prescribed Minimum Benefits (PMBs) (Standard / Ultra Affordable)** – DSP applicable / Non-DSP will reject.
